## **Public Works**

Trustee Reed shared that a pre-construction meeting will be held this week on South Holland 2017 MFT Road Resurfacing projects, which include 167<sup>th</sup> Street from Drexel Avenue to Ellis Avenue, 167<sup>th</sup> Place from Cottage Grove to Greenwood Avenue, Avalon Court off of 169<sup>th</sup> Street, 171<sup>st</sup> Court east of Paxton and lastly the entrance road to Paarlberg Park. Sidewalk and curb removal and replacement will be part of this improvement project.

President De Graff asked if there were any additional business.

Trustee De Young shared that he met a group of baseball players from Peoria having dinner at Andy's Grill, after playing ball in one of our ball fields. They shared how much they loved our fields.
