Evangelist Betty G. Wilson from Breaking of Bread Fellowship, Ministry, Inc. opened our meeting with prayer. President De Graff thanked Evangelist Wilson.

President De Graff presented a Proclamation honoring retiring ESDA Deputy Director, Ralph Turner.

Minutes

Resident Comments

Ms. Linda Howell, 15306 Ingleside, expressed concerns regarding a party that took place on her street with an excessive numbers of guest spilling out of the house. This was a party with adults and it ended around 1:00 AM. Neighboring lawns were left with bottles and other debris the next morning. She reported that the police were called and that the responding officer had a difficult time getting down the street. Ms. Howell shared that such a large number in one concentrated area would have been a problem had there been a medical emergency in the area. Chief Baker will meet with her to get more details and to discuss what should be done moving forward.

Ms. Jackie Franklin, 265 E. 173rd Place, asked what the Village and other governing bodies were doing regarding stagnant water in the deep tunnel. President De Graff explained that we and the other surrounding communities are working with MWRD to make sure we get the highest attention and we will be happy to provide her with an update after we have more information.

Vivian Tracey, 170th Greenwood, expressed concern regarding a section of her street that is sinking and her sidewalk which is buckling. Director Gunkel shared that there was a water main break on her street and that a section of the street was cut out to make the repair. The street was repaired and it is settling. President De Graff informed her the Public Works will come out and do an evaluation the area.

A **Resident** expressed concerns about groceries stores that have closed in neighboring communities. She wanted to know whether new stores would be replacing those closed stores. President De Graff explained neighboring communities done share such information, therefore we cannot account for the business plans of other communities however we do have excellent grocery stores here in town with no plans for closing. Trustee De Young, highlighting the stability of our stores by sharing that Jewel had just invested in the repaving of their parking lot and Aldi has also had work done.
