Public Safety

Trustee Johnson shared that the South Holland Fire Department has finished this year's Citizens Fire Academy with the final class being held last Thursday in Calumet City at their training facility. The academy participated in live fire drills and a vehicle extrication. We will be having a graduation ceremony on Saturday October 6th at 9am prior to the start of our annual open house. All are welcome to the celebration.

The Fire Department Open House will take place on October 6 at Fire Station 1, from 10am to 1pm. Attendees can tour the station, climb in the fire trucks and ambulances, and meet and eat lunch with the South Holland firefighters.

The Fire Department's annual Parade of Lights is next Tuesday, October 9 at 7pm. This is a tribute to fallen firefighters. There will be a brief public service at Thorn Creek Reformed Church, followed by the parade. The parade winds through the streets of South Holland, Thornton and Homewood.

As school is now back in session, the Police Department would like to remind residents and dog owners to be aware of children walking to and from school. It is important to assure that all dogs are safely secured on an owner's property or if owners are out walking their dogs, it is mandatory that the dogs be secured by a lease or chain of no more than six (6) feet in length and of sufficient strength to restrain the dog.

Also, the South Holland Police Department is working diligently with all schools to assure that the safety and well-being of all students remain a priority.

Public Works

Trustee Reed reported that preventative maintenance has begun on all diesel trucks and larger water pumps for the upcoming winter. Also, Public Works crews have been cutting down dead tree's in the parks and parkways throughout South Holland. Lastly, new soccer goals were assembled and installed at Paarlberg Park for the fall season.
