#### **Resident Comments**

Ms. Elizabeth Jenkins, 17129 Bennett, shared her appreciation for the wonderful response from the police fire departments after she was involved in an accident. President De Graff shared that there are some ways we can help.

#### **Engineer's Report**

Mr. Hilsen had three items this evening. The first item was an **IDOT Local Agency Agreement for Federal Participation to Improve Van Dam Road Intersection.** This is an agreement between IDOT and the Village to jointly participate in cost sharing at 80% Federal Funds and 20% Local Funds for the Construction and Construction Engineering for the Van Dam Road Improvement. This agree is required by IDOT in order for the Village to participate in the Federal Aid Program. Trustee Reed moved to approve the **Agreement** as presented. Trustee Johnson seconded the motion.

The second item was an **IDOT Engineering Services Agreement for Van Dam Road Intersection Improvement.** This is an agreement that authorizes Robinson Engineering to perform Construction
Engineering services for the Van Dam Road Intersection Improvement. Trustee Reed moved to approve the **Agreement** as presented. Trustee Johnson seconded the motion.

The third item was a **MFT Resolution for Improvement under the Illinois Highway Code**. This designates Motor Fuel Tax funds that 20% local match of the cost of construction and construction engineering for the Van Dam Road Intersection improvement. The budget is not to exceed \$524,000. Trustee Reed moved to approve the **Resolution** as presented. Trustee Johnson seconded the motion.

The first item was a **Resolution authorizing the annual agreement with Cook County for food service inspections.** This resolution authorizes the Cook County Environmental Health Division to provide inspection on all food services establishments and retail food stores licensed in the Village. #### **Public Safety**

Trustee Johnson shared that the South Holland Police Department would like to remind residents of section 10-152 of the Village Code. The code references the parking of vehicles during snowstorms. No person shall park any vehicle for a period of time longer than three minutes for loading or unloading of passengers or thirty minutes for loading and unloading of property on any street at any time after snow

begins to fall and for a period of eight hours after snow stops falling, if the snow on the street exceeds two inches in depth. This restriction continues until snow removal operations are completed. For any questions regarding this ordinance, please contact the South Holland Police Department and ask to speak with the Watch Commander.

#### **Public Works**

Trustee Reed had no report this evening.
